Are you a pastor, elder, deacon or trustee of a participating church within the Central Valley Baptist Association? A participating church is one that contributes its time, talents, and financial resources to the missional efforts of the Association.

If your congregation meets this threshold requirement, your church is eligible effective January 1, 2019 to apply for an interest free loan not to exceed \$20,000.00, and amortized over a maximum three-year period.

Your CVBA Finance Committee will evaluate your loan application on a case by case basis taking into consideration: (1) the rationale for the need; (2) the priority of the need; (3) your church's current financial picture; and (4) your church's capacity to repay the loan.

APPLICATION FOR PASTORAL DEVELOPMENT GRANT

Are you the senior pastor or associate pastor of a participating church within the Central Valley Baptist Association? A participating church is one that contributes its time, talents, and financial resources to the missional efforts of the Association.

If your congregation meets this threshold requirement, you are eligible to apply for a Pastoral Development Grant.

Yes, grants of up to \$1,000 are available in 2019 for pastors and/or their wives for professional development and ministry encouragement. An approved grant may be used for conference fees, travel to and from a conference, a hotel room, and incidental costs. But a grant doesn't require that you travel. You might want to register for an on line course, or purchase professional development materials. And these are just examples of the way such a grant may be used. Just tell us your proposal for your professional development and/or ministry encouragement.

ASSOCIATION STAFF, OFFICERS, MINISTRIES AND COMMITTEES

Section 3. Finance/Budget Committee

- A. This committee shall be composed of the Association Treasurer and four members nominated by the Nominating Committee and elected annually by the Association.
- B. This committee shall be responsible for the administration of the budget of the Association. It shall make recommendations on all financial matters pertaining to the work of the Association.
- C. This committee shall receive recommendations from the three Program Team leaders through their respective team members and the Personnel Committee for budget considerations.
- D. This committee shall present its budget recommendation to the Executive Board for review and advice.
- E. This committee shall finalize and recommend the annual budget to the Association.

Section 4. Personnel Committee

- A. This committee shall consist of the five members composed of the Moderator and four members who will be nominated by the Nominating Committee and elected annually by the Association. A representative from the Finance Team will attend when salaries and new budgets are discussed
- B. The committee's responsibilities shall be in full cooperation with the Director of Missions
 - 1. To recommend to the Association policies, procedures, job descriptions and salaries for all Associational employees.
 - 2. To survey the need for additional personnel.
 - 3. To interview, recruit and recommend to the Association employees except the Director of Missions.

Section 5. Camp Board Committee

- A. The Camp Board Committee shall be composed of three people nominated by the Nominating Committee and elected annually by the Association
- B. This committee shall represent the Association at the District Camp Board meetings to plan, administer, and evaluate the operation of the District Camp

E. The Team Leader will give a report of their work at each of the Executive Board meetings.

F. The Team Leader will present a report at the annual meeting.

Article III Operational Committees

Section 1. Nominating Committee

A. This committee shall consist of five members appointed by the Moderator and the Director of Missions at the closing session of the Annual meeting.

B. This committee shall nominate all officers, committees, committee members and team leaders for the coming year from member churches who meet the criteria of membership in Article III, Section 1 of the Constitution

C. This committee shall work with the Executive Board to fill all vacancies in the organization and committees of the Association at any regular or called meeting of the Executive Board

D. This committee shall present its recommendations for Associational officers, and standing committee chairpersons for the succeeding year at the Annual meeting of the Association. (The three Program Team leaders will be nominated at the Mid-Annual meeting as directed in Article I, Section 1., a.)

Section 2. Credentials Committee

A. This committee shall be composed of five members nominated by the Nominating Committee and elected annually by the association.

B. This committee shall function according to the provisions of the Articles III, Section 5.

C. This committee shall provide for supervision of the registration table of messengers at the Mid-Annual and Annual meetings.

Section 2. The Multiplying Team

- A. The Nominating committee shall recommend annually at the Mid-Annual meeting a leader for the Multiplying Team. The Team Leader, DoM and Nominating Committee will work together to appoint team members as needed.
- B. The team shall work with the DoM to evaluate areas of need, help plan work to meet the need and help implement the plans to encourage and assist CVBA churches in multiplying mission plants (church starts) and missional sending groups (harvesting/discipling small groups).
- C. The Team Leader will submit their budget recommendations to the Finance Committee by August 1 for the following year's work.
- D. The Team Leader will present projected training/events for the upcoming year to the Executive Board prior to the Executive Board's September meeting for their review.
- E. The Team Leader will give a report of their work at each of the Executive Board meetings.
- F. The Team Leader will present a report at the annual meeting.

Section 3. The Pastoral Health Team

- A. The Nominating Committee shall recommend annually at the Mid-Annual meeting a leader for the Pastoral Health Team. The Team Leader, DoM and Nominating Committee will work together to appoint team members as needed.
- B. The team shall work with the DoM to help evaluate areas of need, help plan work to meet the need and help implement the plans facilitate the health of pastors in the CVBA utilizing pastor cluster groups, seminars retreats, at the annual meeting.
- C. The Team Leader will submit their budget recommendations to the Finance Committee by August 1 for the following year's work.
- D. The Team Leader will present projected training/events for the upcoming year to the Executive Board prior to the Executive Board's September meeting for their review.

Article I – Authorization and Decorum

Section 1. This Association shall have the right to adopt such bylaws or rules of decorum as may seem necessary and amend the same from time to time by a two-thirds majority vote of the messengers present at an Annual meeting.

Section 2. Decoru

A. The current edition of Robert’s Rules of Order shall be the guide in all matters pertaining to the conduct of the business sessions of the Association.

B. A parliamentarian shall be appointed by the Moderator at the closing session of the Annual meeting to serve for the year and through the succeeding Annual meeting.

Article II Program Teams

Section 1. The Equipping Team

- A. The Nominating Committee shall recommend annually at the Mid-Annual meeting a leader for the Equipping Team. The Team Leader, DoM and Nominating Committee will work together to appoint team members as needed.
- B. The team shall work with the DoM to help evaluate areas of need, help plan work to meet the need and help implement the plans to encourage and assist CVBA churches fulfill the Great Commandment and Great Commission by equipping disciple-making-disciples.
- C. The Team Leader will submit their budget recommendations to the Finance Committee by August 1 for the following year’s work.
- D. The Team Leader will present projected training/ events for the upcoming year to the Executive Board prior to the Executive Board’s September meeting for their review.
- E. The Team Leader will give a report of their work at each of the Executive Board meetings.
- F. The Team Leader will present a report at the annual meetin

This Constitution may be amended by a two-thirds majority vote of the messengers present at the Annual meeting, provided that a copy of the proposed amendment shall have been submitted to the Executive Board for its review and advice. Upon approval of the Executive Board, copies of the proposed amendment(s) will be sent to all member churches at least forty-five (45) days prior to the Annual meeting. Copies of the proposed amendment(s) shall be available to all messengers upon registration at the Annual meeting.

Article VIII—Meetings

Section 1. This Association shall meet twice annually for conducting business.

Section 2. The Executive Board may call additional meetings of the Association if necessary, or change the time and place of meetings of the Association when the Executive Board deems it necessary to convene at the time or place appointed.

Section 3. The program of the Annual and Mid-Annual meetings shall be planned by the Executive Board in conjunction with the DoM and publicized to the churches no later than thirty (30) days prior to the meetings.

Article IX – Recognition of Organizations

Section 1. The Association shall organize Ministry Teams which correspond to the ministries, purposes, and objectives of the Association. The Association shall allow time at the Annual meeting for the Ministry Team leaders and Associational program leaders to make reports and discuss pertinent information of their ministry.

Section 2. The Ministry Teams will plan their goals, strategies, budget, and calendar for the following year's work. The items will be presented at the Annual meeting.

Section 3. At the Annual meeting any additional organizational leaders and committee members shall be elected.

Article X – Director of Missions

A. Duties/Responsibilities

- I. Supervise the Associational staff.
- II. Work with the Associational Moderator to appoint the members of the Nominating Committee at the Mid-Annual meeting.
- III. Be free, along with other missionary staff, to be guided by the Holy Spirit into places of service in the assigned field to fulfill the Association's objectives.
- IV. For a more detailed description of the duties and responsibilities of the DoM, see current Job Description on file in the Associational office.

IV. The Executive Board will

A. Recommend to the Association a DoM, his salary and job description.

B. Supervise the work and hold responsible the DoM, using the latest, voted upon Job Description, for the work of the Association.

C. Vote on the selections provided by the Nominating Committee to fill all vacancies in the Association committees and ministry teams at any regular or special called meeting of the Executive Board.

D. Vote on the annual plans presented by the Ministry Teams prior to the Annual meeting. These plans will be presented at the Annual meeting.

E. Recommend to the Association an annual calendar of Associational activities.

F. Vote on and recommend to the Association the annual budget.

G. The Executive Board will hear and respond to reports given by the Ministry Teams, Treasurer, and any other areas of responsibility and business of the Association, at each quarterly meeting.

H. The Executive Board will be notified of the agenda for each meeting at least one week in advance. (For called meetings, notification of the agenda will be two weeks in advance.)

Section 3 – Purpose

The purpose of the Executive Board will be to supervise the work of the Association Office. Specifically, it will supervise the DoM of the CVBA. The DoM will oversee and supervise the day-to-day operations of the staff and volunteers of the Office of the Association and work with the churches of the CVBA to fulfill the objectives and purpose of the Association. The ministries, purpose, and objectives will consist of the following categories:

Multiplying Team: will assist, equip, and work with our CVBA churches to multiply congregations and missional sending groups. This team will also coordinate mission endeavors at the local, state, national and international levels.

The Equipping Team: will serve and strengthen the health of our CVBA churches in fulfilling the Great Commandment and the Great Commission, i.e. making disciples that make disciples.

The Pastors' Health Team: will supply resources and guidance to facilitate the health of pastors in the CVBA utilizing pastorcluster groups, seminars, retreats, and mentoring.

The Ministry Team leaders shall be elected annually at the Mid-Annual meeting upon recommendation from the Nominating Committee and the DoM.

Section 4 – Operations/Functions

I. The work of the Association Office shall be under the supervision and direction of the DoM, with exception when there is no DoM, then the Executive Board's officers will serve in that capacity until a new DoM is selected.

II. The Executive Board will meet at least quarterly.

III. A quorum to conduct Associational business shall be constituted by the elected officers (as stated in Article VII, Section 2) and the elected members, equal to one half of that number plus one. No business or vote can take place unless there is a quorum.

Section 8. In the absence of the Moderator the Vice-Moderator, Clerk, or Treasurer, in the order named, shall act as Moderator for the meet-ing.

Article VII – The Executive Board

Section 1 – Authority

- The Central Valley Southern Baptist Association was incorporated on 21 December, 1949 and the Executive Board created shortly thereafter.

The authority of the Executive Board to make decisions regarding the CVBA is therein granted to include:

Financial: Up to 25% of the general (nondesignated) funds can be spent upon a 2/3 vote of the Executive Board.

Calendar: The Associational calendar can be modified to include changes to dates and times. No changes shall be made to the Annual and Mid-Annual meetings, unless emergency issues arise. Changes must be with a 2/3 vote of the Executive Board (see Article VIII—Meetings).

Section 2 – Membership

- I. The Executive Board shall consist of the duly elected officers of the Association (namely the Moderator, Vice-Moderator, Clerk and Treasurer), the Multiplying Team leader, the Equipping Team leader and the Pastors' Health Team leader, the Finance Team chair and the Nominating Team chair, and a maximum of nine (9) pastors and/or members from approved churches. The DoM will be an Ex Officio member of the Executive Board. No one church will have more than two (2) representatives on the Executive Board. Those pastors and members serving on the Executive Board will be recommended by the Nominating Committee and elected by the Association at the Annual meeting.
- II. The nine (9) elected members of the Executive Board will serve a term of three (3) years on a rotating basis.
- III. After serving the three year term, a member will rotate off for one year before being eligible to serve again, unless otherwise agreed upon for a further term as voted by a quorum of the Executive Board (the member is recused from this vote).
- IV. Members of the Executive Board must be present and participate in a minimum of 50% of scheduled and called meetings to remain active on the Board

Article VI – Officers

Section 1. The officers of the Association and the Executive Board shall consist of a Moderator, Vice-Moderator, Clerk and Treasurer, all of whom shall be elected (annually). The Moderator shall be elected for no more than three consecutive years. These officers shall be the legal (Trustees) officers of the corporation. These officers will become members of the Executive Board of the Association.

Section 2. It shall be the duty of the Moderator to preside over the deliberation of the Association and to discharge such duties as are usually incumbent upon the presiding officer of deliberate bodies. He shall appoint all operational committees unless the Association shall otherwise direct. The Moderator will work with the Director of Missions, (hereafter referred to as DoM in this document) to appoint the Nominating Committee at the Annual Meeting. The Moderator shall serve as the chair of the Executive Board and will deliver a report at the Annual Meeting of the Executive Board's decisions during the past year and any other pertinent information related to the Central Valley Baptist Association.

Section 3. The Vice-Moderator will serve alongside the Moderator and serve as Chair in case of Moderator's absence. He will assume all duties and responsibilities should the Moderator be unable to complete his term.

Section 4. It shall be the duty of the Clerk of the Association to keep a record of the proceedings of the Association and the Executive Board and to file and keep in order, all papers considered important by the Association and the Executive Board. The Clerk will also report attendance at the Executive Board meetings and will notify the Director of Missions (DoM) and Moderator should a member miss more than two (2) meetings.

Section 5. The Treasurer will see that no funds are diverted from the cause for which they were designated unless directed, in writing, by the Association or the Executive Board at one of the called meetings. He/she will receive and keep a strict account of all Associational funds and shall make such reports to the Executive Board. The Treasurer shall be bonded (paid for by the Central Valley Baptist Association).

Section 6. The books of the Clerk and the Treasurer shall be open for inspection, by appointment, by any member of a church contributing financially to the Association.

Section 7. The election of officers of the Association shall be held at the Mid-Annual meeting. These officers will assume their duties at the close of the Annual meeting.

Subsection i__ adherence to believer's baptism by immersion

Subsection ii__ making and training disciples for the furtherance of the Great Commandment and the Great Commission

Subsection iii__ prayerfully consider to giving at least 2% of the church's budget to the work of the CVBA

Subsection iv__ to support and participate where able in the association's participation of building God's Kingdom through revitalization, church health and development of a farm system

Section D__ Each church is encouraged to supply an annual report consisting of basic metrics such as attendance, tithes, baptisms, etc. to assist the association in measuring the health of the CVBA and where to allocate resources and assistance to accomplish its goals.

Section E__ Churches failing to agree or comply with these Articles will be asked to meet with members of the Executive Board to discuss the issues at hand with the goal of resolution and continued fellowship within the association. Where an impasse occurs or no resolution can be agreed upon; the full Executive Board body will determine whether said church shall remain a part of the association.

Article IV – New Churches

Section 1. New churches desiring admission into the fellowship of this Association shall make application for such by a petitionary letter to the Executive Board of the Association. Section 2. When a church makes application for fellowship into this Association by a petitionary letter, the Moderator shall instruct the Credentials Committee to inquire into their articles of faith, manner and nature of organization, and fellowship. Upon a favorable report from the committee, the Moderator shall call for a vote by the Executive Board, or at either the Annual or Mid-Annual Meeting. The Clerk of the Association shall notify the church of the decision in writing.

Article V – Authority

Section 1. This Association shall not exercise any authority over the autonomy of the local Church.

Section 2. While this Association does not assume any authority over the autonomy of the local Church, it does however reserve the right to discontinue membership with cause of any church in the Association.
